#### Westwood & Bales PTO Treasurer's Report

- Monthly Highlights/Fundraising recap-
  - Westwood and Bales Cares raised \$365 for School Supply Donations and \$50 for "Stock the Fridge" for teachers convenience. The \$365 raised for school supply donations will be combined with the \$642 balance remaining from last year's WWB Cares donations to cover a majority of the cost of 12 extra school supply packages provided to counselors at Westwood and Bales for distribution to families in need.
  - As of August 31, we've received \$2,250 in Round Up Sponsors and \$3,893 in t-shirt and ticket sales. Expenses paid to date total \$1,842.65.
  - Kindergarten, 1st and 5th grade socials brought in a combined \$1,797.45 in ticket sales throughout July and August.
  - Spirit Store brought in \$8,963.79 in sales and an additional \$585 recorded in September.
    \$8,866.41 cost of inventory will clear in September and remaining inventory will be sold at upcoming events and through online flash sales. In addition to general inventory, we provided Spirit Shirts for staff totaling \$1,776.96.
  - Software subscriptions paid during August include \$402.95 annual DropBox fee, \$449 annual PTO website fee, and monthly \$31.98 Quickbooks fee. We're discussing transferring files saved from DropBox to Google Drive in order to eliminate this fee.
  - The PTO purchased Legacy Benches for Bales outdoor playspace totaling \$1,233.
    These items were purchased to fulfill the Legacy benches offered during last year's silent auction.
  - Rent for our storage space has increased to \$268 per month. This storage unit is used heavily for Merry Mustang Market, Silent Auction, Gala, and other annual events. We're discussing alternative storage spaces, such as a portion of the outdoor trailer previously used as the music room.
  - A charge of \$250 made to Venmo New York on 8/15/23 is currently in dispute with Venmo. This charge was not approved or detailed in our PTO Venmo account. If Venmo is unable to resolve this charge, we will move forward with disputing the charge through HomeTown Bank.
